It is an honor to inform you registration of a project under the JCM (Joint Crediting Mechanism) between Viet Nam and Japan.

Project title: Eco-Driving by Utilizing Digital Tachograph System

The project was registered on 4 August 2015 at the 4th Joint Committee held in Hanoi, Viet Nam, where representatives from both countries attended. Eco-drive promoting system using digital tachographs is applied to 124 trucks in use by NIPPON EXPRESS (VIETNAM). Fuel consumption will be reduced by improving the driving behavior based on continuously analyzed data through cloud network. The project is expected to reduce 1,776 tCO₂ by 2020 in total.

This project is the first JCM project registered in Viet Nam.
